
# The Consulate General of Canada in Miami


Approx 70 DND personnel are stationed at various bases in the state










### **Exports to Canada Total \$6.5 Billion**






**Total Exports (\$M)** 






## 25% of Tampa MSA's \$5.7 Billion Exports\* go to Canada

### **Exports to Canada Total \$371 Million**




### Southwest Florida Exports to Canada by County








### **588,685** Jobs Linked to Trade With Canada\*



### **124,478** Jobs Linked to Trade With Canada\*





### \$3.8 Billion Real Estate Purchased By Canadians\*






Canada's real estate portfolio in Florida totals **US\$53 billion**.

Canadians contribute over **US\$500 million** in property taxes annually.





### \$202 Million Real Estate Purchased By Canadians\*







